- * **Transfers:** Transfers are available through the cruise line from Copenhagen to the cruise ship on scheduled days of arrival and departure. The round-trip transfer cost from Copenhagen to the cruise ship is \$60 per person payable with final payment. **Your flight itinerary must be faxed to our office in order for us to make your transfer arrangements.**
